**ORDINANCE LEVYING AND ASSESSING TAXES OF
HUNTLEY FIRE PROTECTION DISTRICT
MCHENRY AND KANE COUNTIES, ILLINOIS FOR 2025**

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Huntley Fire Protection District as follows:

Section One: That the sum of SIXTEEN MILLION EIGHTY-SIX THOUSAND DOLLARS (\$16,086,000) be assessed and levied from and against all taxable property within the limits of the Huntley Fire Protection District as the same is assessed and equalized for State and County purposes for the current year, 2025. The specific amount hereby levied for each object and purpose is set forth as follows:
