ORDINANCE LEVYING AND ASSESSING TAXES OF HUNTLEY FIRE PROTECTION DISTRICT MCHENRY AND KANE COUNTIES, ILLINOIS FOR 2024

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Huntley

Fire Protection District as follows:
